Introduction

Installation must be in accordance with the following steps and stated specifications and implemented by suitably competent personnel. This device is intended to be part of the safety-related control system.

Maintenance

Frequency	Description
Every week	Check the correct operation of the switching circuit. Also check for signs of abuse or manipulation. Inspect the unit for damage. Replace the unit if damage is apparent.
At least every six months	Isolate all power. Check for any sign of wear or damage, for example, cam assembly wear, contact oxidization and replace if apparent. Clean out any accumulation of fine dirt and so on. Lubricate code barrel assembly with light oil or spray (for example, WD-40) or alternative product suitable for application. Assessment of operating environment can require the unit to be lubricated more frequently. Reinstall the power and check for correct operation.

Repair

If there is any malfunction or damage, do not attempt to repair. Replace the unit before machine operation is allowed.

IMPORTANT Do not dismantle the unit.

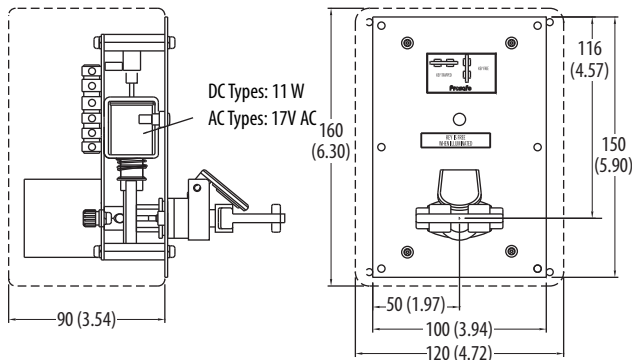

Figure 1 - Mounting

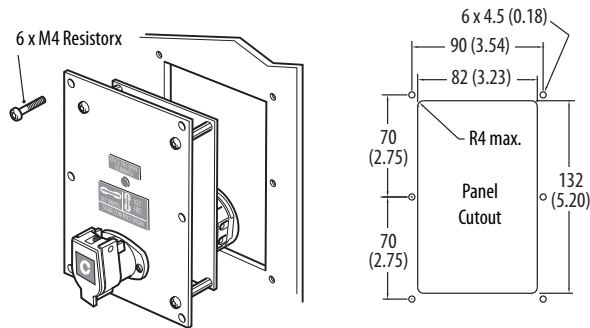


Figure 2 - Assembly

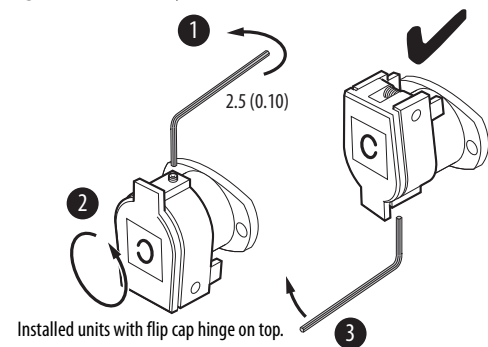


Figure 3 - Operation

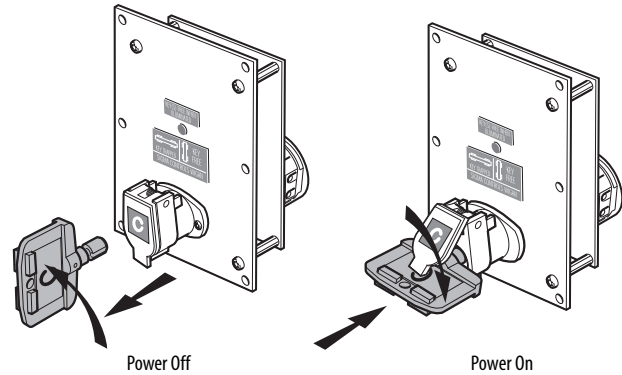


Figure 4 - Signal Input

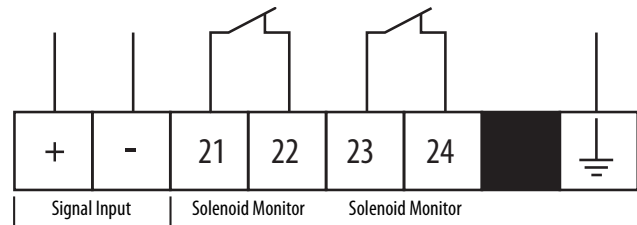
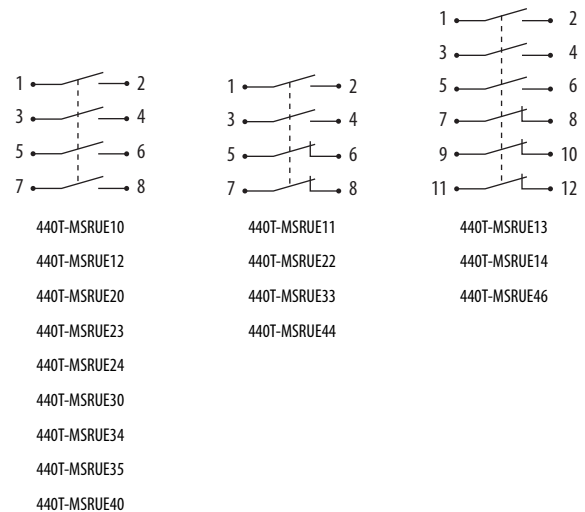


Figure 5 - Diagrams Shown with Key Free
